Statement of Intent

Woosah United is about choice, respect, and access.

We exist to create a calm, supportive, and uplifting community where people can explore holistic health, healing, and wellbeing in ways that feel best aligned for them—rooted in love, support, shared humanity, and connection.

Woosah United honors personal choice and shared humanity, while remaining centered on wellbeing and community rather than external agendas.

Choice belongs to the individual.
Woosah United provides the space.

What Woosah United Is

Woosah United is a community-centered wellness collective that brings together individuals and businesses to connect, collaborate, share offerings, and engage with the public in an open and respectful way.

Woosah United does not exist to determine what is right or wrong, valid or invalid, effective or ineffective.

Our role is to hold space, foster connection, and support access to a diverse range of wellness- and business-related offerings.

Shared Space & Participation

Woosah United focuses on creating respectful shared spaces—both in person and online—where members and the public can interact openly and comfortably.

Members are encouraged to:

- Engage with others respectfully
- Communicate offerings clearly and honestly
- Support an environment where individuals can explore offerings without pressure or expectation

Woosah United values openness, ease, and personal choice within the community.

Services & Offerings

Members may offer any services or products they choose within their individual businesses.

When participating in Woosah United:

- Members choose which offerings they wish to share within the community
- Members are encouraged to describe offerings clearly so individuals can make informed choices
- Members are not required to present or promote every service they offer

Participation in Woosah United does not imply endorsement of any specific service, product, or outcome.

Connection, Referrals & Resource Sharing

Woosah United encourages organic connection, collaboration, and mutual support among members.

From time to time, members or leadership may share referrals, recommendations, or resources—such as practitioners, services, suppliers, or business-related vendors—based on familiarity, experience, or community connection.

These suggestions are offered as options, not endorsements or guarantees, and individuals are encouraged to make their own informed choices.

Use of the Woosah United Name & Platforms

Woosah United provides a shared platform for connection and visibility.

Members agree to:

- Represent themselves and their offerings truthfully
- Avoid implying that Woosah United endorses or guarantees specific outcomes
- Respect that Woosah United is a shared space serving a diverse community

Woosah United exists to provide access, not authority.

Leadership & Stewardship

Woosah United operates under a stewardship-based leadership structure focused on maintaining a calm, welcoming, and community-centered environment.

Leadership exists to:

- Hold and protect the shared space
- Support calm, respectful engagement, connection, and collaboration
- Encourage sustainable growth of the community
- Ensure Woosah United spaces remain open, welcoming, and community-centered

Woosah United provides structure and space, not direction or control.

Agreement

Participation in Woosah United reflects a shared understanding that:

- Individuals are responsible for their own choices
- The community is strengthened through respect and openness
- Woosah United provides space, not direction

By participating, members agree to uphold the spirit and intent of this community.

Community Governance, Limitation of Liability & Legal Boundaries

Non-Endorsement & Limitation of Liability

Woosah United serves as a collaborative community and networking collective only. Participation or membership does not imply approval, certification, endorsement, or oversight of any member's business practices, products, services, or professional claims.

Woosah United shall not be held responsible or liable for any damages, losses, disputes, or outcomes arising from interactions between members or between members and the public.

No Professional Advice

Woosah United does not provide medical, legal, financial, or professional advice. Any information shared within the community—including discussions, posts, events, workshops, or resources—is for general informational purposes only and should not replace consultation with qualified professionals.

Independent Businesses & Personal Responsibility

All members operate independently and are solely responsible for their own businesses, practices, representations, compliance, and interactions.

Woosah United is not a party to transactions, agreements, or disputes between members or between members and the public.

Assumption of Risk

Participation in Woosah United—including engagement in discussions, events, collaborations, referrals, or shared opportunities—is voluntary and undertaken at each individual's discretion.

Members assume responsibility for their participation and any outcomes resulting from their choices.

Non-Discrimination & Inclusion

Woosah United is committed to maintaining a respectful, inclusive community. Participation and access are not restricted based on race, color, ethnicity, national origin, religion, spiritual belief, sex, gender, gender identity or expression, sexual orientation, age, disability, or any other protected characteristic.

All members are expected to engage with one another respectfully and without harassment, discrimination, or exclusion.
