(General – Applies to All Future Events)

Purpose & Scope

This Event Participation & Liability Addendum (“Addendum”) applies to any in-person, virtual, or hybrid events, gatherings, workshops, markets, classes, or activities that may be offered from time to time through Woosah United.

This Addendum is intended to establish general expectations and boundaries for event participation. It does not guarantee that events will be offered, nor does it create any obligation for Woosah United to host or provide events of any kind.

This Addendum supplements the Woosah United Member Participation Guidelines and applies only when an individual chooses to participate in an event.

Voluntary Participation

Participation in any Woosah United event is entirely voluntary.

Each individual is responsible for deciding whether to attend or participate in any event and for determining what feels appropriate for them based on their own circumstances, health, comfort level, and personal judgment.

Independent Responsibility

All participants acknowledge and agree that:
